DID YOU KNOW?

In 1986, Governor Booth Gardner & the Washington State Legislature created a "continuously renewable resource known" to "assist low and very low-income citizens in meeting their basic housing needs." It's called the Washington Housing Trust Fund and is administered by the Washington Department of Commerce. Over the last just over 30 years, it's invested more than \$1 billion in the development of 47,000 affordable housing units across every county in the State. 2/3 of the households living in those units have income of 30% less or area median income & more than ½ have at least one member with special needs. Every dollar allocated by the Fund leveraged \$5 of other investments from private investors, local government, banks, and yes, HUD. Thanks to 30 years of hindsight. It's clear the Governor & Legislature had a great idea. As the Fund enters its 4th decade, may its successes ahead be even greater.
